

PRIVACY POLICY

For us, LIGNA PROPERTIES Ltd., as a personal data administrator, the protection of personal data of our customers is of particular importance. We are aware of our responsibility to you, which requires processing of your personal data to be lawful, clear and transparent. By adopting this Privacy Policy, we define and declare to you how this process shall take place so that your data to be protected. By visiting the website <https://missia23.com> and using it, you accept this policy without objections and additional conditions.

LIGNA PROPERTIES Ltd. applies the following principles set out in Regulation 2016/679 (GDPR) and the Personal Data Protection Act in the processing of personal data of any individual, regardless of the form:

- (a) legality, good faith and transparency;
- b) limitation of objectives;
- (c) data minimization;
- d) accuracy and timeliness;
- (e) restriction of storage;
- (f) integrity and confidentiality;
- g) accountability.

1. Basic definitions

For the purposes of this policy, the following terms defined in Regulation 2016/679 (GDPR) are used:

A data controller is a natural or legal person, public body, agency or other structure that alone or jointly with others determines the purposes and means for the processing of personal data.

Personal data processor is a natural or legal person, public authority, agency or other entity that processes personal data on behalf of the controller.

A data subject is an identified natural person or an identifiable natural person (a 'data subject').

Personal data is any information by which a data subject can be identified unambiguously. These are the name, identification number, location data, identity document data, online identifier, information on the physical, physiological, genetic, mental, intellectual, economic, cultural or social identity of that individual.

This Privacy Policy describes how your personal information is processed in the event that you provide your information through the contact form on the site.

This Privacy Policy is in accordance with Regulation 679/2016 (GDPR) and the Personal Data Protection Act in the Republic of Bulgaria.

PERSONAL INFORMATION

When you visit <https://missia23.com> it automatically collects certain information about your device, including information about your web browser, IP address, time zone and some cookies that are installed on your device. In addition, as you browse the site, we collect information about the individual pages or products you browse, what sites or search keywords have directed you to <https://missia23.com> and information about how you interact with the site. We call this automatically collected information "Device Information". The site collects information about your device using the following technologies:

- Cookies - data files that are automatically installed on your device or computer and often include an anonymous unique identifier. For more information about cookies and how to disable cookies, visit <http://www.allaboutcookies.org>
- Log files - track site activity and collect data, including your IP address, browser type, internet service provider, redirects / landing pages, and date and time log
- . - Web beacons, "tags" and "pixels" are electronic files used to record information about how you browse the Site.

HOW DO WE USE YOUR PERSONAL DATA?

When you are on our site <https://missia23.com> we use the information about the device to help us identify potential risks (through your IP address), as well as to improve and optimize the site (for example, by generating analyzes about what you view, how you interact with the site, and how to evaluate the results of our marketing and advertising campaigns). We also collect device information to deliver relevant content and ads to partner sites, and to measure or understand ad performance. When you leave your details through the contact form (name and surname, telephone number, e-mail), we will contact you to find out what you need and to offer you the best offer for it. We may process the following categories of your personal data:

1. Communication data that you send to us, incl. provide us with any personal information you choose, whether by email, text message (SMS), social media messages, social media posting or other communication channels. We process this data in order to contact you, to identify bad faith and for legal protection.

2. User data, which includes data on how you use the site. We process this data to effectively manage the site - to ensure its security, to maintain backups of the site, as well as to ensure that you provide faster and easier access to personalized content for you, based on an analysis of your interaction with site.

3. Technical data - includes data on the use of the site, your IP address, your login details, details of your browser, duration of your visit to the site, navigation paths, details of the number of visits to the site, time zone settings of devices that you use to access the site. The source of this data is collected from a tracking analysis system. We process this data in order to analyze the use of the site, its administration and protection, as well as to provide you with interesting content and ads.

We may also use the types of data described above to provide you with relevant content and ads (including ads on Facebook, Instagram, LinkedIn, etc.) to measure your ad performance. The legal basis for this processing is our legitimate interests, which include expanding our business.

THIRD PARTY SERVICES

We do not disclose your personal data to third parties, except in a situation where the third party is part of the provision of a service for you. The third-party providers we use will only collect, use and disclose your information to the extent necessary for them to perform the services they provide to us. HOW DO WE GET YOUR CONSENT?

When you provide us with personal information by filling out the contact form on the site, you declare that you agree with the types of personal data processing that we perform related to the specific purpose specified in the contact form.

YOUR RIGHTS

According to Regulation 679/2016 (GDPR) and Personal Data Protection Act you have the following rights:

- The right to be informed that your data is being processed, what type of processing is being carried out, how long your data is being stored, for what purposes it is being processed, what measures are being taken to secure it;
- The right to access your personal information - you have the right to access your stored data and to the data that were processed at the time of your request;
- The right to request from the Personal Data Administrator access to, correction or deletion of personal data or restriction of the processing of personal data - You have the right to request that your incorrect, incomplete, inaccurate or outdated data be corrected;
- The right to object the processing – E.g. you may object the use of your e-mail for direct marketing purposes;
- The right to data portability - you have the right to request from LIGNA PROPERTIES Ltd. to provide a structured, widely used and machine-readable format for data transfer;
- The right to withdraw consent at any time - You can withdraw your consent to the processing of personal data without having to argue. Withdrawal of consent does not affect the lawfulness of prior processing;
- The right to appeal to a supervisory authority - You have the right to lodge a complaint or objection with the supervisory authority in the country:

- The right to be forgotten - You have the right to request that your personal data be deleted if you believe that the processing is illegal or if you believe that the personal data

provided are no longer needed by LIGNA PROPERTIES Ltd. In some cases, however, the company will retain personal data if necessary to ensure the legality of its activities and compliance with legal and regulatory requirements.

STORAGE OF PERSONAL DATA

We will retain your personal information only for as long as is necessary to fulfill the purposes for which we collected it, including for the purposes of meeting all legal, accounting or reporting requirements. When deciding the exact time to retain data, we consider the volume, nature and sensitivity of the data and transactions, the potential risk of unauthorized use or disclosure, the purposes of the processing and whether ensuring our legitimate interests can be achieved by other means and under other legal requirements. For tax purposes, the law requires us to store basic information about our customers (including contact information, identity, financial data and transactions objectified through payment documents) for five years. In some circumstances, we may anonymize your personal data for research or statistical purposes, in which case we may use this information indefinitely without further notice.
